There are two options for completing this form:

1. Type directly into the form and print the form using the "Print Form" button at the end of this document. Then, share the completed form to share with family and friends.
2. Print the form and complete it by filling it out with pen. Then, share the completed form to share with family and friends.

ABOUT THE SECTIONS IN THIS FORM

The form has been grouped into sections so that important and often related details are easy for people to find. All of the fields are suggestions of information you might document, but none of the fields in this form is required information to complete the form and print it if you are typing in the information.

Please note: This form can be used as many times as you'd like therefore you may complete the form in its entirety for your closest family or friends and only complete some of it for others.


